Center for Translational Medicine Receives \$1.7 Million Gift-in-Kind

The School's Center for Translational Medicine (CTM) has received a \$1.7 million gift-in-kind from Certara. Certara renewed their partnership with CTM through this gift-in-kind of software licenses, workshop assistance, and other training sessions for faculty, staff, and students associated with the center. Certara and the School have enjoyed a strong partnership since 2012. This recent gift will combine CTM's research, clinical, and educational expertise with Certara's IT infrastructure with the ultimate goal of generating new, innovative approaches to improve population health. Research performed by Vijay Ivaturi, PhD, of the CTM on enhancing the software was a key driver of this grant.

Faculty and Students Make a Difference on Capitol Hill

Faculty and student pharmacists from the School of Pharmacy were visible on Capitol Hill in September as they represented the pharmacy profession through their participation in health fairs, meetings, and testimonies - all with the goal of promoting the pharmacist's unique expertise and capabilities in improving patient outcomes and reducing health care costs. On Sept. 17, our faculty and students participated in the pharmacy profession's 2nd annual Health Fair on the Hill, which was designed to inform legislators and their staff about the many services that pharmacists can provide to help individuals maintain healthy lifestyles and prevent and manage chronic illnesses. Our faculty and students provided bone density screenings for legislators and their staff members. On Sept. 24, I was honored to speak to members of Congress about pharmacy education, licensure, continuing education, and H.R. 4190, a bill that seeks to amend the Social Security Act in order to provide coverage of pharmacists' services under Medicaid. Also testifying on Capitol Hill in September was [Nicole Brandt, PharmD, MBA, CGP, BCPP, FASCP](#), a professor in PPS, who was asked by the coalition Partnership for Part D Access to testify about the importance of maintaining beneficiary access for older adults to the full range of available medications under Medicare Part D. Faculty, staff, and students from the University of Maryland School of Pharmacy gathered in Pharmacy Hall on Sept. 17 for the American Pharmacists Association (APhA) Foundation's inaugural Pinnacle Awards Innovations in Pharmacy Practice Lecture. Presented by representatives from El Rio Community Health Center, a 2014 Pinnacle Award recipient, the lecture spotlighted best practices in pharmacy practice innovation, raising awareness about how clinical pharmacy services can be implemented within health care organizations. The APhA Foundation established the Pinnacle Awards in 1998 to celebrate significant contributions to the medication use process. The awards are divided into three categories that recognize individuals and groups for their efforts to enhance health care quality and improve medication use among patients.
