Two Faculty Honored with USM Board of Regents Awards

Two faculty members from PPS were recipients this spring of Faculty Awards in Mentoring and Public Service from the University System of Maryland (USM) Board of Regents. <u>Jill Morgan</u>,

PharmD, associate professor and former associate dean for student affairs, received the USM Board of Regents Faculty Award in Mentoring for her tireless efforts to coach, advise, support, and mentor students in the School's Doctor of Pharmacy (PharmD) program and residents in the Pediatric



Pharmacy Residency Program, for which she serves as director. As associate dean for student affairs from 2005 to 2013, Dr. Morgan was


instrumental in the expansion of the School's PharmD program to the Universities at Shady Grove, implementing the use of video conferencing between campuses and advocating for students' access to services such as on-site advising, tutoring, career development, and counseling and registration services. She also recognized the need to make student pharmacists more competitive in the job market, overseeing the creation of the School's Job Ready Program, which helps equip students with the tools and resources necessary to develop high quality resumes, enhanced networking skills, and superior interview techniques.

The USM Board of Regents Faculty Award for Public Service was given to Bruce Anderson, PharmD,
DABAT, associate professor in PPS, in recognition of his service as director of operations for the Maryland Poison Center (MPC). A center within PPS, the MPC is certified by the American Association of Poison Control Centers as a regional poison center. It operates 24 hours a day, every day of the year, and is staffed by pharmacists and nurses who are certified as specialists in poison information. Though the Center initially only served

physicians when it first moved to the School of Pharmacy 41 years ago, it has grown into a free public service that now responds to more than 60,000 calls from Maryland residents each year. Read more here...

PPS Faculty Member Named Co-director of UMB Center for Interprofessional Education

Heather Congdon, PharmD, BCPS, CDE, associate professor and the School's assistant dean at the Universities at Shady Grove (USG), has been named a co-director of the new Center for Interprofessional Education (IPE) at the University of Maryland, Baltimore (UMB). The Center is directed by Jane M. Kirschling, PhD, RN, FAAN,

dean and professor of the School of Nursing, and monitors all of the IPE initiatives in which faculty, staff, and students at UMB are engaged. Since Jay A. Perman, MD, was named president of UMB in 2010, IPE has been one of the cornerstones of the University's strategic plan. With faculty, staff, and students represented in almost all of the University's IPE initiatives -including its IPE Task Force, first-ever IPE Day, interprofessional student competitions, as well as School-wide interprofessional courses and committees -- the School of Pharmacy has become one of the campus' leaders in this key area. At USG, Dr. Congdon also co-leads the Committee on Interprofessional and Interdisciplinary Education Strategies (CIPES). Launched in 2007, this committee has developed several elective courses, workshops, and other events to sharpen both undergraduate and graduate students' skills as interprofessional learners. Its Interprofessional Approach to the Critically III Patient elective is wildly popular among pharmacy, nursing, social work, and
